It allows the user to perform all operations with just one hand, while wearing gloves. Wrench covering every possible 3/4" application. Its double-hammer offset punch system is suitable for all types of tightening operation, even for low-torque applications. It has energy-consumption levels nearly 40% lower than standard 3/4" wrenches. This wrench coupled with the flexible multi-flow accessory (Ref. 19015-MF) regulates the flow to 200 or 400 l/mn. It saves compressor power and can generate air consumption savings of up to 60% . Suspension ring. The ATEX regulation (Explosive Atmospheres) stems from two European directives (ATEX directive 94/9/EC for equipment and 1999/92/EC for human safety). The ATEX directive (2014/34/EU) has been compulsory since 20/4/2016 and is tending to become the baseline in terms of safety, even outside the EU. (zones 11, 12, 21 and 22)
